The inner cover containing quotations and other relevant documents alongwith DD towards Earnest Money Deposit (EMD) should be sealed properly. The inner cover should be put in on outer cover and may be dropped in the box kept in the office of the NCCF of India Ltd., Kolkata Branch at 27, Mirza Ghalib Street, 4th Floor, Kolkata – 700016. Both the inner and the outer covers should be superscribed in bold Capital letters "QUOTATION FOR DISPOSAL OF OLD VEHICLE ON NCCF".
