- The contractor shall engage an authorized person at site who shall take
 the instructions from the NCCF of India Ltd. The work should not suffer
 due to lack of supervision, manpower and materials.
- 2. The Contractor is required to co-ordinate his works along with other agencies working at site. He has to reimburse any of the damage made by him or any of his representatives for any of the other agency or owner at site.
- 3. Making of any cut-out / opening for electrical wiring / fitting in any of false ceiling, partition, Paneling, masonry work etc., and providing panels of the same finish in partitions, paneling shall not be paid extra.
- 4. The contractor is required to fabricate a sample where required, or any item so installed for approved. Any changes made by the NCCF of India Ltd. in the sample to the specifications as mentioned in the tender, shall not be deducted or paid extra.
- The partitions shall be so fixed that all joinery work is in plumb and true in line. The partition frame shall be firmly fixed to the floor and ceiling by using suitable wall plugs and screws
- 6. The contractor shall check all dimensions before fabricating and fixing the partitions orceiling in position at site.
- 7. All measurements given in the schedule hereunder are for the purpose of tender only. Payment will be made on actual measurement of the work done. All measurements shall be as per relevant I.S.I. standards.
- 8. All materials to be used on the work shall be of reputed makes/ISI marked, as per the NCCF guidelines.
- Cement, steel, fabricated material etc. required for the works will have to be arranged by the contractor, and his own cost.



- 10. All taxes as applicable shall be deducted from the bills of contractors.
- 11. The contractor will have to get samples of material and all fittings approved by the Engineer-In-charge NCCF for his representative before using them of the work.
