- 2. The guidelines issued by (DOCA) and NCCF pertaining to procurement should be followed by the empanelled registered Societies/Vendors and amendments if any from time to time.
- 3. Offer should include society commission charges per quintal. Commission charges will be negotiable on MSP.
- 4. The proposal received from the Societies /Vendors will be scrutinized, the quantity and areas of procurement operations will be allotted subject to acceptance of the terms and conditions.
- 5. All the PSF guidelines/DOCA/NCCF/State/Central Govt. rules and regulations pertaining to procurement under the above mentioned scheme will be applicable to all the Empanelled Intermediary Agencies.
- 6. Allotment of the Quantity and areas of procurement the final decision reserves with NCCF.
- 7. Societies /Vendors should provide area of interest like District Name, Taluk Name and Quantity to be procured based on availability of the crop.
- 8. Societies/Vendors has to execute the agreement with NCCF and if fails to execute the agreement within the stipulated time then the allotted quantity will be terminated.
