- 1-Bids are invited from interested parties (SEEDLICENCEE) for the sale of certified seeds lying at Reengus Rajasthan. Interested bidders are requested to submit the bid in sealed/closed envelope along with EMD and tender fee. The successful bidder has to deposit advance payment within 5days, in case of no receiving of advance payment within 5 days the EMD will be forfeited. Bidder shall have to lift stock of seed within a week time after deposing the cost of seed.
- 2-NCCF shall be at liberty to distribute 40 % of the total tendered quantity of materials amongst other than L1 bidders subject to acceptance of L1 rates by other than L1 bidders and fulfilment of eligibility criteria by them if offer for complete 100% is not received as per technical eligibility condition.
