- 1. Bids are invited from interested parties (SEEDLICENCEE) for the sale of certified seed of Barley lying at Morena Madhya Pradesh. Interested bidders are requested to submit the bid in sealed/ closed envelope along with EMD and tender fee. The successful bidder has to deposit advance payment within 7 days, in case of no receiving of advance payment within 7 days the EMD will be forfeited. Bidder shall have to lift stock of seed within a week time after deposing the cost of seed.
- 2. NCCF shall be at liberty to distributed upto 40% of the total tendered quantity of materials amongst other than H1 Bidders subject to acceptance of H1 rates by other than H1 bidders and fulfilment of eligibility criteria by them if offer for complete 100% is not received as per technical eligibility condition.
- 3. NCCF shall terminate the empanelment of a Business Associate if they have competed against NCCF in any bid either individually, as a partner or in joint venture.
- 4. First preference shall be given to empanelled Business associate of Tendering Branch of NCCF. Second Preference (in case of absence of valid Business Associate of Tendering Branch) shall be given to empanelled Business Associate of other NCCF branch, and third preference shall be given to Non-Empanelled Business Associate. NCCF shall be at liberty to postpone / cancel the tender and accept or reject any bid without assigning any reason.
- 5. Bidder shall submit seed license with offer along with EMD details and tender Fee
