TENDER NOTICE

NCCF Delhi Branch invites Tender from Empanelled Millers/ Processors for supply of Pulses in Himachal Pradesh and Uttarakhand at various locations within stipulated time period after processing/ milling, packing and transportation etc in two bid system (Technical & Financial).

1. NAME OF WORK:- Transportation, milling and packing of Pulses in consumer packing of 1kg packets as per FSSAI specifications for distribution/ sale to consumers.

2. SCOPE OF WORK:-

Job work for transportation, milling / processing & packing cost for supply of Gram, Chana Dal, Arhar Dal, Moong Sabut, Moong Dal, Urad Sabut, Rajma, Massor Sabut and Malka to H P State Civil Supplies Corporation ltd, Himachal Pradesh and Govt of Uttarakhand at various locations within stipulated time period in 1 kg packing strictly conforming to the prescribed standards and norms of Food Safety and Standard Act, 2006 rules and amendments at about 110 locations in both the states separately. The bidders have to submit the rates in given formats (enclosed state wise).

- Supply of pulses shall be in one kg (Nett Weight) of Low density plastic pack laminated with polyester in HDPE bags to the destinations/ godowns of HP
 State Civils supplies Corporation ltd, Himachal Pradesh and Uttarakhand within stipulated time period from the date of issuance of order of the HP State Civil Supplies Corporation ltd, Shimla and Govt of Uttarakhand.
- 2. Supply only good quality pulses, strictly conforming to prescribed standards and norms of Food Safety and Standard Act, 2006, Rules and amendments, will be accepted. The supply of pulses will be in HDPE (High Density Polythene) bags containing 25 packets of one kg. The plastic bag of one kg must be in conformity with the provisions of Food Safety and Standards (Packing and Labelling) Regulations to Supply only good quality pulses, strictly conforming to prescribed standards and norms of Food Safety and Standard Act, 2006, Rules and amendments, will be accepted. The supply of pulses will be in HDPE (High-density polyethylene) bags containing 25 packets of one kg. The plastic bag of one kg must be in conformity with the

provisions of Food Safety and Standards Act, 2006 and the Food Safety and Standards (Packing and Labelling) Regulations, 2011, more particularly Chapter-2 thereof, where upon the word" in Hindi letter intimated later" and "Net Weight, 1 Kg and "MRP per Kg with all taxes" as per rates conveyed by the NCCF should be printed. In addition to this, all information as per the Legal Metrology Act, 2009 and Food Safety and Standards Act. 2006 and regulations there under, must be written on each packet i.e. name and full address of the manufacturer/packer, name of commodity, Net Weight, MRP including all taxes commodity and month & year of the packing of the commodity.

- 3. The plastic used for the packaging of item should be of non-toxic material as well as of high quality. Declaration in this regard must be printed in each pack. The quality of packed pulses should remain unchanged in respect of size, shape, quality, colour and should be free of fungus and moulds etc. for at least six months and each packet of pulses shall have to super scribe the words "The pulse for the next month will be provided to the consumer only after return of the empty plastic pack to their fair price shop":
- 4. The packing of Pulses should be in accordance to the samples provided by you and approved by the HP State Civil Supplies Corporation ltd, Shimla and Uttarakhand Govt.
- 5. The bidder shall be allowed to retain the by-products produced as result of milling/up gradation of the un-milled stock of Chana, Masoor, Moong, Arhar, Rajma and Urad.
- 6. The bidder shall hire the transporter/ agent for transportation.
- 7. The successful bidder should deposit the cost of un-milled pulses with NCCF account prior to the last date of submission of the funds.
- 8. Payment will be released after realisation from HP State Civil Supply Corporation and Uttarakhand Govt. against supplies.
- 9. Offer price shall be given state wise in the format (attached Annexure 1 & 2) separately.
- 10. The bids shall be submitted in 2 bid format i.e. Technical Bid and Financial bid. Financial bid will be opened only for technically qualified bidders.

Eligibility Criteria

- 1. The Bidder should have minimum experience for supply of 10,000 MT of packed pulses in 1 kg packing to any government department/ agency/ PSU during any 1 of the last 3 financial years. Documentary evidence for experience has to be submitted with the bid i.e. completion certificate duly certified by the concern department.
- 2. The turnover of bidder in pulses for last 2 audited financial years should be above 250 Crores minimum each year. Documentary evidence have to be submitted with bid (A turnover certificate from CA to be submitted).
- 3. The bidder needs to submit last two years audited balance sheets and Income Tax Returns.
- 4. Net worth of the bidder should be 10 Crores minimum for last audited financial year (duly certified by CA).
- 5. The offer of all Bidders must remain valid for the period of one year and thereafter the same may be extendable for a period of 1 year with discretion of NCCF.
- 6. All applicable taxes/ entry tax/mandi tax etc alonwith 1.50 % NCCF administrative charges shall have to be included while submitting the bid. For any changes in the administrative charges whether increased or decreased shall be applicable from effective date.
- 7. All terms and conditions of MOU entered into between NCCF and H P State Civil Supply Corporation & NCCF and Govt of Uttarakhand shall be applicable on bidder as it is, as applicable on NCCF.
- 8. After finalization of the bid, the bidder shall have to make contract agreement with NCCF immediately.
- 9. Factory License should be submitted by the bidder.
- 10.FSSAI License should be submitted by the bidder.
