Sir / Madam,

- 1. Please be informed that National Cooperative Consumers' Federation of India Ltd. (NCCF) has been playing significant role in Agri marketing sector in the country. Schemes announced recently by Govt. of India focus on strengthening logistics and infrastructure throughout the country. NCCF under its objectives can develop warehousing space for storage of Agriculture products in India in close association with its Member Societies. There are several warehouses of varying storage capacity developed by NCCF from its own resources. Most of them have been leased out to private parties / Govt. agencies like CWC for different purposes.
- 2. For the non/semi perishable agriculture commodities, there exists a three tier storage structure in the country. While at the primary level, there are nationwide storage organisations including FCI and CWC, which operate till the point of aggregation of few Districts in different State, at the State Level till Districts, there are organisations such as SWCs and other agencies such as Markfed etc. However, at the village level there are smaller godowns generally maintained by village / district level organisation. Though in the initial two categories, the storage structures are generally well taken care of by regular operation and maintenance, it is the village level structures which are often in poor conditions in various States mainly due to lack of maintenance and financial resources with the managing organisations.
- 3. The above arrangement, besides putting a burden of transportation immediately to the hub warehouse location for the commodities by the farmers, also deprives the small scale farmers who are not capable of producing a minimum vehicle load of commodities for transportation independently to such large warehouses, thus often subjecting them to the distress sales and depriving them of the opportunities for better price realisation through sales in the lean seasons and availing other benefits such as collateral finance etc. which would have left them with cash at hand immediately after harvest and thus preparing them for next crop in a better way.
- 4. Govt. of India has announced commencement of Agriculture Infrastructure Fund (AIF) scheme with an outlay of Rs. 1 Lakh Crore to provide assistance for development of Agriculture Infrastructure. The development of warehouse space is an eligible infrastructure under AIF, NABARD under Agriculture Marketing Infrastructure Scheme which has been providing subsidy for development of warehouses.

- 5. NCCF is regularly undertaking procurement operation of Paddy, Wheat, Pulses, Oilseeds and other food commodities in the major producing State under MSP and PSS scheme. At times, the State Warehousing Corporation / Central Warehousing Corporation do not have sufficient warehousing capacity for storing the procured Commodities and have to resort to hire warehousing space from private warehouses quite far from the procurement centres. It is also essential to have warehousing space closer to farm gate and railway station for quicker & cheaper evacuation.
- Keeping all the above objectives and opportunities in mind, an Expression of Interest (EoI) for empanelment of franchises for development of Agriculture infrastructure under NCCF is being invited. Copy of the same is enclosed for your ready reference please and the same can also be downloaded from NCCF Website i.e. www.nccf-india.com,
- 7. The franchisee is to preferably be a member cooperative society or FPO. Private Companies however Individual can also apply. The infrastructure has to be developed by the party (preferable owned / leased or in certain cases land allocated by NCCF or land allocated in a Food or logistics park / terminal). The franchisee would be making all the investment and will be responsible for construction of infrastructure, obtain loan in their name and be responsible for servicing the loan.
- 8. NCCF on its part of responsibility will oversee the development of infrastructure by engaging a third party professional agency. NCCF will also appoint a third party service provider like CWC etc. for managing the infrastructure and operations and will assist the applicant with Govt. agencies / Financial Institutions to get loan or grant or subsidy.
- 9. NCCF will be responsible for marketing the infrastructure so developed and put to use on "Best Endeavour basis" with no minimum guarantee of its usage. For this purpose a separate tri partite agreement shall be signed between NCCF, Agency and Applicant / Owner. The income generated out of the venture would be shared between franchisee, NCCF and any other entity as per the project specific financial agreement with the franchisee.
- 10. The franchisee is expected to plan develop and construct warehouses, silos, cold storage, pack house, ripening chamber etc. The infrastructure is to be developed in an area closer to the production centers and where the availability of the infrastructure is non-existing or insufficient in comparison to the production and procurement. An individual SPV / company may need to be formed with respect to each project in the overall NCCF infrastructure brand and a bipartite agreement shall be signed between the Applicant / Owner and NCCF.
- 11. Once the warehouses are developed, we may request Central / State Govt. to utilize the NCCF warehouses on first priority basis so that the developed infrastructure is put in use and all the other associated expenses are minimized to a larger extent. Even in case of no procurement in a particular year or no public procurement also, the project shall be chosen in such a way that the production in that region is stored by the private players in the infrastructure developed and is optimally utilized.
- 12. All warehouses are expected to be WDRA complaint and accredited with possibility to expand vertically / horizontally, involve latest construction technique and state of art facilities like conveyor belt for loading / unloading, air conditioning (for cold storage) etc.

- 13. It is expected that franchisee base infrastructure, mainly warehouses, may be developed under this Expression of Interest inviting proposal each with a minimum of 1000 MT capacity making a total of at least 5 LMT warehouse space under NCCF infrastructure brand.
- 14. We at NCCF propose to commit ourselves to following activities for development of the business:
 - a) Undertaking feasibility study for identification of suitable locations besides preparation of DPR template.
 - b) Developing proposals and assisting state Primary Agriculture Cooperative Societies (PACS), Marketing Cooperative Societies, Multipurpose Cooperative Societies in submission of proposal under AIF Scheme.

c) Developing proposal for supply chain services / building e-market platform.

- d) Identifying and suggesting convergence of fund opportunities from other Central / State Govt. schemes for the identified projects.
- e) Undertake study and formulate project for supply chain infrastructure requirement of new / existing, crop clusters / exports clusters.
- f) Comprehensive assessment of project intent, content and viability including preparation of business plan and detailed project report besides helping in financing of project.
- 15. You are therefore, requested to give wide publicity to this scheme amongst the stakeholders in your area and invite interested parties for participation in this activity. In case your society is interested to set up warehousing facility as envisaged above, please free to get in touch with Shri Shaukat Ali, General Manager (Commercial) (email: Business@nccf-india.com) who would take the proposal forward for our mutual benefits.

Empanelment of Franchisee for developing agriculture infrastructure by interested entities preferably cooperatives / Farmer producer Organisations / Private individuals/companies involved in Agriculture related activities including procurement operations / agriculture products aggregation / Logistics Operations/Grain Management. The empanelled franchisees are expected to Plan, develop and construction of agriculture infrastructure including Warehouse / Silos / cold storage / pack house / Ripening Chambers etc. which are eligible for obtaining assistance under Agriculture Infrastructure Fund of Government of India, closest to the production / consumption centers across India.
- 2. The franchisee looking for empanelment should preferably own land or hold land under registered lease deed for a minimum period of 30 years.
- 3. Preference will be given to location(s) which are close to a National / State Highway / within or nearby rail siding or Freight Terminal.
- 4. The land should necessarily be in close proximity of major agriculture crops producing /consumption areas.
- 5. The purpose of this EOI document is to provide interested parties with the relevant information/invite regarding the project and understand the scope of the Project and invite feedback from interested and eligible vendors. The applicants are advised to study this EOI Document carefully before submitting their feedback & suggestions in response to the EOI Notice. The feedback & suggestions received as part of the response from the participants to this EOI Document may be used for further preparation of project specific Detailed Project Report for development of infrastructure if found suitable.
- 6. This is an open ended empanelment process. The interested parties may provide relevant details if they feel are eligible. NCCF would revert to applicants based on merits of the application.

3) Introduction and Background

National Cooperative Consumers' Federation of India Ltd. (NCCF) was established with the objectives to organize, promote and develop marketing, processing and storage of agricultural, horticultural and forest produce, distribution of agricultural machinery, implements and other inputs, undertake inter-state, import and export trade, wholesale or retail as the case may be and to act and assist for technical advice in agricultural, production for the promotion and the working of its members, partners, associates and cooperative marketing, processing and supply societies in India.

NCCF intends to set up Agriculture infrastructure solutions across India based on details provided in the empanelment document.

The infrastructure solutions has to be developed by the party on their own land (owned or leased on long term) or in a land allocated by NCCF on long-term dedicated basis or land allocated by Freight Terminal or Logistics Park.

Tentative locations for setting up of infrastructure solutions, would be as per the need of NCCF and determined based on commercial feasibility of the project and its utility to the stakeholders.

The key objective is to:

- a. To provide the modern agriculture infrastructure which are accredited by agencies like Warehouse Development Regulatory Authority (WDRA).
- b. To reduce the total cost and gestation (concept to commissioning) period of setting up infrastructure solutions having logistics facilities preferably with rail connectivity with all basic amenities, security system, boundary walls, gate complex, office blocks, electricity, water supply, sewerage system, approach roads, etc.

Description of EOI Process:

- a. The stage of Expression of Interest (EOI) is undertaken as an industry consultation to determine credible partners having requisite capability for undertaking the Scope of Work, to provide their inputs on the key parameters to be adopted by NCCF which would help determining the terms and conditions for the selected locations. The terms and conditions will be specific to each project depending upon the location, requirement etc.
- b. The applicant is free to propose any location with complete description and justification for setting up of infrastructure solution, based on production of any item(s)/ commodities handled by NCCF or other such agencies, its consumption or any other reason(s). If found suitable, NCCF may consider all

- or some of the locations for further deliberations to develop infrastructure, but the same is not binding on NCCF.
- c. Applicants will be required to provide details of the suggested locations so as to make NCCF well acquainted with the facility/location before preparation of DPR.
- d. The suitable locations derived from the empanelment process would be further scrutinised for its commercial viability and utility to the stakeholders. If found suitable, the party would provide all the required documents for preparation of DPR for submission to Agriculture Infrastructure Fund (AIF) for assistance under the scheme.
- e. The DPR would be submitted to the financial institution for obtaining credit facility to develop the infrastructure and apply for assistance under AIF.
- f. Only those projects which are found to be eligible for funding under AIF would be pursued further.
- g. The Party has to begin the development of infrastructure and meet the timelines as agreed by NCCF and as per the AIF scheme guidelines. Essence of the timelines is to put the infrastructure to use at the least possible time.

4. Scope of Work

All investment in the project will be the responsibility of the applicant.

The applicant will be responsible for taking all approvals including regulatory, for implementation of the project. Applicant is responsible to pay all the taxes, statutory fees/levies either one time, over a period of time or periodically w.r.t. infrastructure created under the proposal.

Applicant would be responsible for construction of the infrastructure. The construction of infrastructure should adhere to the specified norms and standards of NCCF and any of the applicable standards /guidelines.

NCCF would be overseeing the development of infrastructure through a professional agency so as to ensure strict adherence to norms and standards.

The infrastructure solution to be developed with provision for expansion of capacity – vertical or horizontal or a mix thereof. It should be using the state of the art technology, having complete automation in majority of activities, remotely operable/networkable, energy efficient, environment friendly, requiring minimal manual operations.

The Infrastructure solution to be developed may limit its lending to the extent of Rs 2 crore in order to gain maximum assistance under AIF.

NCCF will be responsible for marketing the infrastructure so developed and will put to use on best endeavour basis with no minimum guarantee of itsusage.

To manage the infrastructure and operations, NCCF will appoint the third party solution provider.

NCCF will assist the applicant with Government agencies/financial agencies to get Loan/Grant/Assistance/Subsidy if any for such projects. The Grant / Assistance / subsidy thus obtained will be construed as the contribution of NCCF into the respective project.

The revenue generated through the project would be shared between the franchisee and NCCF and any other entity (if required), as per the project specific financial agreement with the franchisee.

The infrastructure developed under this proposal would be having association with NCCF for the period specified in the project specific financial agreement with the franchisee and not less than the period of loan term.

The franchisee is solely responsible for the loan taken by the financial institution and its servicing / payment of interest and principal. Franchisee is responsible to execute other conditions as required to be met under AIF.

Franchisee agrees to completely indemnify NCCF of any financial liability arising out of the arrangement under this proposal.

Depending on the specific project arrangement, NCCF may bring in equity in terms of cash or land etc. which would be explicitly mentioned in the project specific financial agreement with the franchisee. The shareholding pattern of NCCF in a project would be equal to any such equity and the Grant /Assistance / subsidy obtained with the help of NCCF.

The Applicant should be eligible to get assistance under AIF. Applicant are advised to study the AIF scheme, guidelines, DPR and other details to make themselves acquainted with the requirements of scheme and fulfil the same.

The Applicant should be legally competent to enter into contract as per the prevailing Indian law.

The applicant should own requisite parcel of land or should be in possession of requisite parcel of land on long terms lease basis of 30 years or more, with clear land title with no legal/revenue related issues

The land parcel should preferably within the vicinity of 500 mtr to maximum 5 kms of Major District Roads/State Highways/National Highways

The land parcel should be preferably either be within a Freight Terminal/rail siding or in the vicinity of the same.

The land parcel should be in the production/consumption area of crops/commodities handled by NCCF or similar agencies.

7. Information to the Applicant(s) -

There is no timeline for submission of EOI. Partners can submit their EOI from time to time and will be considered by NCCF depending on the infrastructure solutions requirements accordingly.

9. Process of Submission of Application

The application shall be submitted in hard copy of EOI document duly signed by the Authorized Signatory with self-attested copies of the supporting documents at the below mentioned address.

Application documents may be scanned in pdf format.

Applicant who has downloaded the EOI from the NCCF website shall not tamper/modify the EOI application form, in any manner. In case if the same is found to be tampered/modified in any manner, the application will be summarily rejected.

The EOI application shall be in English language. All correspondence and documents relating to the EOI exchanged between the applicant and NCCF shall also be in English language. However, any technical document/ literature etc. printed in a language other than English shall be accompanied by its true English translation duly signed for its correctness. Any document submitted with the application but not in English language shall not be treated as part of the EOI application document. The responsibility for the correctness of the translations if any solely rests on the applicant and NCCF shall not be responsible for any loss/likely loss arising out of error in translation whatsoever. In such cases, for the purpose of interpretation of the document, the English translation shall prevail.

Applications that are received without documents for essential requirements & EMD will be summarily rejected.

10. Completeness of the contract:

10.1 The contract shall be deemed as incomplete if any event is not completed within the stipulated time period or the event is not successfully completed in the manner as specified by NCCF or if any act/event/incident takes place which is attributable to Applicant (s), which results in delay/incompletion of an event or which results in a financial, reputational or other losses to the NCCF.

11. Termination:

There would be a regular review of the performance of Applicant in the panel.

In the event of the Applicant having been adjudged insolvent or going into liquidation or winding up his business or making arrangements with his creditors or failing to observe any of the provisions of this contract or any of the terms and conditions governing the contract, the NCCF shall be at liberty to terminate the contract forthwith without prejudice to any other rights or remedies under the contract and law and to get the work done for the unexpired period of the contract under risk & cost and to claim from the Applicant any resultant loss sustained or costs incurred by the NCCF.

NCCF shall also have without prejudice to other rights and remedies, the right, in the event of breach by the Applicant of any of the terms and conditions of the contract to terminate the contract and/ or forfeit the security deposit or any part thereof and/or invoke the Bank guarantee for the sum or sums due for any damages, losses, charges, expenses or costs that may be suffered or incurred by the NCCF due to the Applicant(s)'s negligence or deficiency or unwork-man like performance of any of the services under the contract. In case the performance of the Applicant is not found to be satisfactory during the currency of the agreement, NCCF can prematurely terminate the agreement after giving one month notice.
