About NECTAR:

The North East Centre for Technology Application and Reach (NECTAR) is an autonomous society, set up under the Department of Science & Technology, Government of India with its headquarter at Shillong, Meghalaya.

NECTAR has been conceived as a collaborative centre of excellence to resolve the last mile problem in the delivery, induction, management, use and extension of technology applications which serve public good and promote social and economic development of the North Eastern region in the broadest possible terms. In order to assist the north eastern region, NECTAR ensures application of appropriate technologies for development in the areas of biodiversity concerns, watershed management, telemedicine, horticulture, infrastructure planning & development, planning and monitoring, and tele-schooling using cutting edge solutions, employment generation through utilization of local products/resources and associated skill development.

Preamble:

In the sector of oilseed cultivation, Mustard is one of the Rabi Crop, Cultivated abundantly in many parts of the North East region. The crop is slowly gaining popularity among the North East farmers owing to its adaptability for both irrigated & rain fed areas. Implementation of Govt. of India's program "Cluster frontline Demonstration under National Mission on Oilseed & Oil Palm" is also bringing a revolution in Mustard Cultivation in the Region. States like Assam, Arunachal Pradesh, Manipur etc. have significant amount of Mustard cultivation areas and the people are cultivating mustard on regular mode during Rabi season in the region. It is learnt that Mustard Flower is highly nectariferous can be explored for Honey trapping.

During the cropping period (flowering stage) the scope of extraction of mustard honey through Honey Bee Rearing for a sizable cluster of mustard cultivation area can be a good option for significant honey production, beside Honey Bee rearing activity can be carried in the proximity region on migration basis through pastoral nature of other seasonal crops such as Sesame, Lichi, Maize and Mango etc., as a good profitable economical activity.

About 50 thousand Bee Boxes are of requirement that can be deployed in various numbers ranging from 100-200 bee boxes per cluster for setting up Honeybee Rearing. Scope of work:

- i. The selected Bidders will be empanelled to supply Honeybee Boxes, stand and other accessories to the beneficiaries in Northeast Region as per the desired technical specifications at the contracted rate.
- ii. The empanelled Manufacturers/Organisations will support in establishing Honeybee manufacturing units in various places of Northeast Region by engaging local entrepreneurs.
- iii. The empanelled Manufacturers/Organisations will provide training and skill development to beneficiaries in Honeybee rearing activities in North-eastern Region.
- iv. The empanelled Manufacturers/Organisations will provide the service of project monitoring and successful implementation of Honeybee Rearing activity in North-eastern Region.
- v. The supply of Honeybee Boxes and services shall be purchased in phase wise manner or on requirement and based on the capacity of the empanelled Manufacturers/service providers.

Bid Registration cost & Bank Guarantee:

- i. A sum of **Rs 5000/-** Non-refundable Bid Registration charge payable in the form of DD in favour of NECTAR shall be paid and enclosed in the Technical Bid documents.
- ii. Performance Bank Guarantee of **Rs. 5,00,000/** (Rs. Five Lakhs only) valid for a minimum period of Two years (up to 31.03.2024).
- iii. Bank Guarantee shall be enclosed in the Technical Bid. - iii. There shall not be any upward revision of rates during the validity period of EOI.

Manufacturers/Suppliers Qualification

While empanelling the manufacturers, the following aspects/terms of reference shall be ensured:

- i. The manufacturer/ organisation must manufacture / produce honeybee boxes and colonies. If the company /organization are manufacturing only bee boxes then they should procure quality colonies from bee breeders/apiary owners and stand, related equipment from manufacturers and supply them as one unit to the beneficiary/NECTAR.
- ii. The companies shall supply honeybee boxes/ colonies and stand, related equipment as per technical specification (Annexure-I) only.
- iii. The manufacturer should have a minimum business turnover of Average Rs. 2500.00 lakhs per annum for the last three consecutive years and should have adequate sale value of number of honeybee boxes/ colonies per year.
- iv. Preference will be given to Micro Small & Medium enterprise (MSME), Start-up entities and Class I local suppliers as per the procurement guidance note published by Dept. of Expenditure, Ministry of Finance, Govt. of India. Relevant proof of documents shall be furnished in the technical bid. Certified copy of Statement of Accounts to be enclosed.
- v. The empanelment will be normally valid for the period one year. The NECTAR reserves the right to restrict/extend the period of registration with or without assigning any reason.
- vi. The area of operation will be for entire North Eastern States. If a manufacturer/organization has limited resources for supply of bee boxes, colony, and stand, the company can restrict his area of operation accordingly to the part not less than one states. The final decisions on area of operation of any company /organization lies with the NECTAR.
- vii. Preference will be given to the manufacturer from North East Region or the company should have a branch in North East Region.

The Manufacturer/ Organizations roles and responsibilities

- i. The honeybee boxes/ colonies and stand, related equipments shall be supplied to the beneficiary in the North Eastern region through NECTAR by the manufacturers/organisations.
- ii. In the event of any damage to parts of the bee box/ stand, related equipment before handing over to the beneficiary, it shall be replaced.
- iii. The Department is free to take strong punitive measures including and not limited to forfeiting of bank guarantee/ security deposits, blacklisting against erring companies, to safeguard the interests of beneficiaries and to ensure effective utilization of public funds.
- iv. The warranty/guarantee for the bee box/ stand shall be at least 2 years from the date of handing over them to the beneficiary by the manufacturer. If any parts of bee box/ stand found to have manufacturing defect or poor workmanship within the warranty period, they shall replace the same free of cost.

Quality Control

- i. Frequent surveillance by inspection teams comprising officials from NECTAR, will be taken up. The random samples will be drawn and checked.

- iv. After evaluating the Technical Bid, the financial bid will be opened for qualified bidders and the lowest bidder's cost will be selected as L-1. The empanelment will be processed after signing of standard empanelment agreement with NECTAR as per mutual terms and condition. Offers of empanelment shall be given to L-2, L-3 etc. if they desire to supply the items in the rates as revealed L-1.

- iii. The farmers/beneficiaries will also be allowed to directly purchase the bee boxes and related equipment from any of the empanelled manufacturer at the approved rate through NECTAR's consent letter.
- iv. The manufacturer shall execute an agreement covering all the Terms and Conditions on a judicial stamp paper (purchased in the name of the Manufacturer) of Rs.200/- or as per the existing procedure at his cost within 15 days from the date of approval of the Manufacturer. The manufacturer is not permitted to supply the items without execution of the agreement.
- v. In respect of any dispute arising out of implementation of this EOI, the decision of the EOI Accepting Authority shall be final.

Technical Specifications:

- 1. Honeybee Boxes: Good quality bee boxes having Technical Specifications as per the standard types of hive, generally used in Indian conditions i.e., Automatic beehive as per Langstroth's hive or India Standard Industries (ISI)/ BIS hive, each type should be capable of 6 frames suitable to species of bees that are most prominently found in northeast region (e.g., Apis Cerana/ Mellifera) and having good productivity (about 1.5-3kg per frame). The boxes made of any kind of good food grade material such as Forest wood/Pine wood/Plastic/Metal etc. are to be supplied. Boxes should have both family chamber and Honey/super chamber. Indicative list of parts of Hives are Bottom board (or) Floorboard, Brood Chamber, Super Chamber, Hive Cover, Hive Cover, Frames, Inner Top Cover, Outer Top Cover, Flow Frame, Flow Key, Flow Key Accesses Slot, Honey Tube (all are suitable size and standard for Langstroth's hive or relevant parts for ISI type hives).
- 2. Hive stand: A four legged wooden, metal pipe or angle iron, rectangular support to the hive.
- **3. Bee Colony:** Each colony of Apis cerana/Mellifea should have minimum of 3 full frames of healthy worker bees and one fertile healthy and young queen bees. About 3000-5000 Bees are recommended.
