

Therefore, interested bidders are requested to participate in the Tender for supply of Gunny Bags and may submit their bids till 25.05.2023 up to 05:00 PM.

- 2. New Small B-Twill Gunny bags as per specification (94 cm X 57 cm, Weight 580 gms) for packing of Pulses of 50 Kg. Printing as per requirement of NCCF and There should be no spillage from the filled bag during the normal handling/ transit etc.
- 3. Samples of gunny bags need to be submitted along specifications along with lab report.
- Transportation for supply of gunny bags to various locations of Gujarat as per the work order place by NCCF, Ahmedabad.
- 5. The gunny bags are to be supplied within prescribed time period from the date of placement of work order for supply by NCCF, Ahmedabad.
- 6. The basic rates per bag shall be quoted on F.O.R basis. (Inclusive Taxes, Levies and Transportation etc if any)
- 7. Offers (Bid) shall be valid for a period of 90 days from the date of opening of Tender during which no escalation in the rates will be allowed.
