NCCF intends to supply 10,000 MT of Wheat to Afghanistan via sea route Kandla Port, Gujrat to Chabahar Port, Iran on turnkey basis for delivery of wheat in 50 KG double bagging directly to the ship at Kandla Port. Cost of purchase of bags, stencilling, stitching, testing, transportation or any other miscellaneous expenditure will have to be paid. The Interested empanelled business associates/ the firm (who wants to be empanelled with NCCF as business associate) of NCCF are requested to submit their budgetary quote to Branch Manager, NCCF, Delhi, 3, Siri Institutional Area, August Kranti Marg, Hauz Khas, Delhi-110016, latest by 01.07.2023 up to 03.00 pm as per details given below:

1. Budgetary quote for procurement of 10,000 MT wheat and source depot/godown for the same.
2. Cost of transportation of 10,000 MT wheat in 50 KG bags from source depot/godown to ship at Kandla Port, by most economical means.
3. Cost of delivery of wheat in 50 KG double bagging directly to the ship at Kandla Port. Cost of purchase of bags, stencilling, stitching, testing, transportation or any other miscellaneous expenditure on actual basis.


Terms & Conditions:
