C) Minimum Eligibility Criteria:-

- Bidders shall be an authorized representative for the supply of the mentioned Scope of Supply as mentioned in (Annexure-1).
- MSME / NSIC vendors are exempted from EMD on submission of valid certificate.

<u>Additional Information: -</u> The clause for waiver of EMD for MSME / NSIC vendors is only applicable to such vendor's who are manufactures/ OEM's of the Services, Vendor's representing their respective OEM's doesn't qualify for EMD exemption.

D) Others :-

- 1. This tender is under TWO (02) Bid System, namely Technical Bid & Price Bid,
- 2. Both Type of Bids should be stamped & sealed in separate envelope clearly marked with the title of Bid.
- EMD should be put in original in "TECHNICAL BID" Closed Cover along with other documents.
- 4. Price Bid should be in a separate sealed envelope, clearly marked as "PRICE BID ONLY"
- 5. Bidders shall ensure that their bids complete in all respects.
- The Price Bids of only those Bidder's would be opened, who qualify the Technical Bid Criteria, as laid down in the Tender Document.

- 8. The prices quoted shall be valid for a period of 90 days from the date of opening of bids.
- 9. In the price schedule, if there is any discrepancy between the unit price and total price the unit, Price shall prevail and the total price shall be corrected by the purchaser.
- 10. The bids will be evaluated by taking the total amount for all the items.

E) Duration of Contract: -

Total (FIVE) <u>05 vears</u>, Renewable on Yearly Basis. The decision to award renewal of contract solely rests upon NCCF DELHI, based on SATISFACTORY PERFORMANCE.

The Annual Charges mentioned in the Price Bid would remain firm for a period of 05 (FIVE Years)

F) Others:-

- 1. The Installation and Commissioning has to be done within 28 days of delivery at or availability of site for installation with all essentials.
- 2. Bids should be clear in all respects and those with ambiguous clauses shall be summarily rejected.
- 3. The supply order will be placed on the lowest responsive bidder.
- 4. Necessary support should be provided as and when required within 2 Hrs. of intimation of problem. Telephonic support should be provided at **24x7**.
- 5. By submitting the bid it is presumed that the bidder has verified the tender Documents and technical specification of the items in details and has quoted the tender rate accordingly.
- Payment will be released within 30 days from the Date of Activation and with legacy of data.
 For claiming this payment, bidder should submit the GST Invoice (in original).
- 7. NCCF DELHI reserves the right to accept or reject any or all of the bids without assigning reason thereof.
- 8. Any dispute arising out of the tender/bid document/ evaluation of bids/issue of purchase order shall be subject to the jurisdiction of the competent court at New Delhi only.
- 9. NCCF DELHI reserves the right to withdraw the Contract for some Services or all Services. In the event, payment would be based on the actual number of Services and its effective period.
