EARNEST MONEY DEPOSIT

Earnest Money will have to be deposited through online payment as in the e-tender portal. Intending bidders shall login to the e-Procurement portal of the Government of West Bengal <http://wbtenders.gov.in> using his login ID and password to make the payment EMD may be paid either by Net Banking through ICICI Bank Payment Gateway or By process of RTGS /NEFT . Memorandum No. 3975-F(Y) Dated-28/07/2016 of the Finance Department (Audit Branch), Government of West Bengal.

Interest free **Earnest Money Deposit (EMD) of Rs.12,000/-(Rupees twelve thousand)** only is to be paid through online in e-Procurement portal.

On processing the financial bid evaluation electronically in the e-Procurement portal, EMD of the technically qualified bidders other than that of the L1 and L2 bidders will be refunded, through the automated process, to the respective bidders' bank accounts from which they made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date

on which information on rejection of financial bid is uploaded to the e-Procurement portal by the tender inviting authority.

However, EMD of the L2 bidder will be refunded through automated process, to his bank account from which he made the payment transaction after the LOI process is successful and L1 bidder accept the LOI. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on Award of Contract (AOC) to the L1 bidder is uploaded to the e-Procurement portal by the tender inviting authority.

PENALTY CLAUSE
