What NCCF is looking forward to?

We hear of E-Commerce being dropped all over the digital world and many people see it as the future of retail. In-ine with this NCCF is looking to replicate the e-Commerce concept through its Online Trading Platform which will provide farmers option to rent agricultural machinery and equipment/product and sell their food grains/other items. The system will cater to a business model that involves rental/payment transactions being done on the web

The portal will work pretty much like how a physical store works Users can rent items, arrange for delivery and payments on the same site with very minimal need to call a human person to help them with their order.

NCCF is looking for a technology partner who will help with design, development, operate, thereby building a good online experience for customers and drive Portal traffic. Once Online Trading Portal is up and running. NCCF will raise awareness, drive traffic and earn sales. NCCF will also take care of the need to process for handling orders and fulfilment once orders start coming in.

Suggested Business Model:

- 1. The model will essentially involve Electronic exchanges of goods and services between businesses and consumers the end users. By adopting this model, here NCCF will show the goods in its online trading platform, customers pick what they like to rent/sell/buy and save items or add them to their carts. When a rental/payment/payment is made, NCCF ship orders to the customers.
- 2 The Technology Partner will be on-boarded as a partner of NCCF. The Technology Partner will not be paid any design, development and maintenance cost of the Online Trading Platform. Instead the per transaction charges that NCCF will be charging for each transaction from Lessor(Seller) (Seller) and Lessee(Buyers)(buyers) will be split with the selected technology partner as per mutual agreement and MOU signed at the start of the project
- 3 In the proposed system it is envisaged that the Lessee(Buyers)(buyers) will be selecting product/equipment/product for the buying/ rental/payment and will be making Advance Payment The the same for. payment advance Lessee(Buyers)(Buyers) will be coming to the account of NCCF and NCCF will convey the same to the Lessor(Seller) (seller) The Lessor(Seller) (seller) will then dispatch the equipment/product to the Lessee(Buyers) as per the mutual shipment agreement between Lessor(Seller), Lessee(Buyers) and NCCF Once the Lessee(Buyers) confirms the receipt of the shipment, NCCF will then make payment to Lessor(Seller) and Technology Partner as per the agreement and MOU between them.

4. All Lessees (Buyers) will be verified by the NCCF through Physical inspection and the address listed by them will be the sole delivery point. The delivery in no case will be happening to any non-listed address of the Lessee (Buyers).

5 All Lessees (Buyers) at the time of their registration will be paying a Security Deposit as specified by NCCF. They will also pay any additional adjusted security deposit (as required) each time at time of respective transaction / order placement This facility will be primarily to safeguard interest of Lessor(Seller) in getting their equipment/product back in right condition and safety.

What Vendor will do for NCCF?

What NCCF will have to do?
