The terms and conditions are mentioned below:

1. Federation / Society will exclusively work for NCCF procurement, storage and dispatch of Rabi 2023 Onion of specified quality and intimated price on daily basis during the procurement period.

2. Board of directors directly/indirectly linked with other federations shall not work with other organizations and FPC are also exclusively work with NCCF.
(Undertaking on Rs 100 bond paper shall be submitted for directors list and List of FPC)

Blacklisting federations will not allowed to participate in the tender .(undertaking shall be submitted in Rs 100 bond paper for non- blacklisting in any other organizations/PSU/semi-Government organizations)

3. That the minimum qualifying A Grade recovery shall be of 52% of the purchased maximum of 28% of B Grade and maximum of 20% to be accounted for storage loss.

Grade- A	Grade-B	Storage Loss
Min- 52 Per Cent	Min-28 per cent	20 per cent

4. That the allocation shall be subject to availability of safe storage space either owned or hired.

5. The minimum storage space available with the procuring federation at one location should be of 500 MT.

6. Storage structure is easily accessible location with the access of transportation facility.(High resolution photographs name of location should be submitted same will be verified at field level)

7. That the allotted target shall be sub-divided in weekly targets. Those not meeting the weekly target, non achievement of the targets quantity will be reduced or contact will be terminated.

8. Bank Guarantee will be decided by NCCF the selected federations letter will be issued based on allotted quantity approximate value of 3 per cent.

9. That the appointed Federation shall comply with the guidelines issued by the Department of Consumer Affairs, Government of India and any amendment thereof, the agreement / MOU signed with NCCF, instructions issued by NCCF, H.O and its Branch from time to time.

10. That the safety of the procured and stored onion both for quantity and quality shall be the responsibility of the procuring Federation.

11. That the comprehensive information of the purchase, payment, storage, dispatch along with all relevant documents, shall be submitted to the Branch. Further, such information's shall be uploaded in the portal / system developed / to be developed by NCCF or its agencies.


12. That the payment released to the Federation shall be utilized only for the purpose for which fund has been provided by NCCF (Separate Bank account will be opened for NCCF related transactions) .

13. Performance will be reviewed periodically if not satisfied contact will be terminated as per the rules of the Federation.

Allocation of quantity will reserves the right to NCCF no claims will be entertained.
