1. ITEMS REQUIRED :

756 Nos. of Double seated Desk-cum-Bench , 36 numbers of Teacher's Table and 36 numbers of Teacher's Chair of Godrej make is required in 10 numbers of Odisha Adarsh Vidyalayas of Koraput District .The detail specification of the above item is enclosed lat Annexure -I , II & III respectively.

2. PLACE AND DATE OF RECEIVING THE TENDER:

Tender shall be received at District Education Office, Paraja Street, Koraput,-764020, District: Koraput ,Odisha, through Registered /Speed Post only on or before 19/10.2022 at 5.00 PM.

3. TENDER PAPER COST:

The intending bidder may apply by downloading bid form and documents from the website www.koraput.nic. and apply accordingly along with Bank Draft for Rs.5000/- (Rupees Five Thousand)only which is non refundable and the DD should be drawn in favour of District Education Officer, Koraput payable at Koraput as cost of the tender paper.

4. EMD:

The intending bidder should submit the EMD of RS.70000/- (Rupees Seventy Thousand) only in shape of Bank draft and the DD should be drawn in favour of District Education Officer, Koraput payable at Koraput. EMD of unsuccessful bidders will be refunded within a period of 30 days after finalisation of the Tender.

5. BID:

The Tender will be in 02 parts i.e. (a) TECHNICAL BID in Annexure-IV and (b) FINANCIAL BID in Annexure-V which are to be submitted in 02 separate sealed covers as per the format prescribed in the BID documents . 7. The Financial bid shall be opened in respect of those bidders who qualify in the Technical Bid.

8. TAX CLEARANCE:

9. AUTHORIZATION :

The bidders should submit the photo copy of Authorization for supply of the Tender items
