Tender Notice

The Department of Food, Civil Supplies and Consumer Protection , Maharashtra Request for proposal food grain (Wheat) suppliers (hereinafter referred to as "Agency" or "Supplier" or "Vendor") to supply wheat at various taluka godowns of 14 district locations for APL (Farmer) Scheme in Maharashtra state.

The Department has monthly requirement of wheat at 14 districts as detailed in Annexure "Supply of Wheat at Various Taluka Godowns in 14 Districts for APL (Farmer) Scheme in Maharashtra" for 7 months or the contract period.

The contract tenure will be for Seven months. The Department, however, reserves the right to terminate / curtail the contract, at any time, by giving one months' notice to the selected agency owing to deficiency of services, sub-standard quality of food grain supplied or for breach of contract condition or non-availability of funds or any other reason whatsoever that may be.

1. Bidder annual turnover during the last three years should be minimum Rs 100 Crores.
2. Financials are 2019-20, 2020-21 and 2021-22 for the turnover last three years (tender for annexure page no.41 in specified format.)
3. For the FY 2021-22 provisional balance sheet and P&L accepted. it should be certified by CA.
4. Bidder should have relevant experience such experience certificates and order copies should be furnished.
5. The experience should be minimum 100 crores.
6. The preference will be given to Cooperative societies.
7. The bidder should have ware house storage facilities and transportation facilities etc. such document proof should be submitted.

8. Bidder should have legal presence in Maharashtra.
9. Along with 4 sets of sample should be submitted. The Non-conformity of sample parameters is liable to rejection of the bid.

1. The bidder should submit the offer in specified format in the tender in company letter head with seal and sign.
2. The offer should indicate NCCF margin.
