Terms and Conditions:

- 1. NCCF, Chennai Branch reserves the right to accept or reject any offer at any stage without assigning any reason thereof.
- Terms and Conditions would remain same as mentioned in the GEM tender no. GEM/2023/B/3505049.
- 3. Rates of the items should be submitted item wise per piece price, GST on goods and Grand Total. Rates of the items should include NCCF margin.
- 4. NCCF, Chennai will not accept the any conditions mentioned by suppliers in their bids.
- The supplier qualified in the technical bid should remit EMD of amount Rs.29,92,000/-(Rupees. Twenty Nine Lakhs Ninety Two Thousand only) in NCCF, Chennai Branch Account through DD/NEFT/RTGS.
- The bidder should be OEM seller/reseller and should similar past experience in the supply of the uniforms past 3 financial years (Before 31st March, 2023).
- The bidder / Manufacturer should have the capacity to supply at least 80% of the tendered quantity of stitched readymade uniforms. Documentary evidence should be submitted.

- 8. Bidder should be the Manufacturers / suppliers of Tamil Nadu. Documentary evidence to be submitted along with the bid. All items mentioned in the tender should be delivered directly to all 434 ICDS Projects in Tamil Nadu.
- 9. The bidders should submit 6 sets of uniforms in each age group (total 18 sets) as samples at free of cost (which will not be returned) before the end date of the bid. Failure to submit samples will lead to rejection.
- 10. The bidder should furnish a quality certificate from any of the listed laboratories mentioned by the Textile Ministry, Government of India on its website stating that the samples submitted along with the bid confirm s to all the specifications stipulated in bid document. The bid inviting authority reserves the right to send the samples submitted by the tenderers to any State Government / Central Government accredited Testing Agency.
- 11. Manufacturer Authorization: Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid
- 12. NCCF, Chennai shall be at liberty to terminate the empanelled Business Associates if it is found that they have competed with NCCF in a particular bid either directly or in partnership/JV with some other firm.
- 13. "NCCF, Chennai will be at liberty to distribute to distribute the quantity of material (40 per cent Maximum) to be supplied among all the technical eligible bidders (bidders who qualify the eligible criteria and have deposited requisite earnest money along with the bids) at the lowest accepted rates by the Tendering organization subject to acceptance of the lowest rates by the bidders other than L1, after acceptance of NCCF's offer by the Tendering organization."
