NCCF invites tender for the empanelment of flour mills and dal mills to supply quality products as per the FSSAI specifications.

Eligibility Criteria:

To be eligible for empanelment, the prospective vendors must meet the following criteria:

- a. The vendor must be a registered and licensed flour mill or dal mill.
- b. The vendor should have an experience in the production and supply of flour and/or dal.
- c. The vendor must comply with all applicable food safety and quality standards.
- d. The vendor should have the capacity to supply **25** metric tons of flour/dal per month.
- e. The vendor must provide a list of references from at least one reputable client.

f. The vendor should provide an undertaking letter confirming the milling capacity and a commitment to offering priority and the best offer to NCCF in future tenders.

g. Ther vendor must provide all the necessary documents pertaining to their firm.

h. Millers and mills should not be blacklisted from any govt. agencies/departments/govt. bodies.

I. The vendor should express a willingness to supply products all over India or in any preferred states at the best rates.

j. The vendor will be registered zone-wise according to their milling setup in any of the zones (East, West, North, South, Central).

k. The vendor must provide a self-declaration stating that "all the documents and undertaking letters are authenticated, and in case of any defaults found in the future regarding the same, the vendor is responsible. All documents should be signed and stamped by an authorized signatory".

Scope of Work:

The empanelled flour mills and dal mills will be required to:

- a. Supply specified quantities of flour and/or dal as per the order.
- b. Ensure quality control measures in the production process.
- c. Comply with packaging and labelling standards.
- d. Adhere to delivery schedules.
