NCCF intends to Supply 1000 MT of Rice to Togo and 1000 MT of Rice to Sao Tome and Principe as Humanitarian assistance as per specification enclosed. The Interested empanelled business associates of NCCF are requested to submit their rates to Branch Manager NCCF, Delhi, 3, Siri Institutional Area, August Kranti Marg, Hauz Khas, New Delhi–110016, latest by 01-06-2023 up to 11:00 am as per details given below:

- 1. Cost of the Rice and transportation charge from India to port of receiving country on a CIF basis: for Togo and Sao Tome & Principe
- 2. Cost of the Rice and Transportation charge from warehouse to India ports on FoB basis.

Terms & Conditions:

- Agency shall ensure the quality of supplies and have it certified through a third party pre-dispatch inspection by any Government Agency.
- Shipment of the consignment by Sea is to be done within 45 days of issuing of purchase order.
- 90% Payment on the production of proof of dispatch by the Agency.
- Balance 10% on delivery of consignment and confirmation of satisfactory receipt, from the Embassy on India. The Embassy of India will issue a joint certification along with relevant authorities of the host Government on the consignment complying with specification, acceptable quality and phytosanitary requirements.
- Original document required to be submitted by the supplier to designated officer of MEA/ Consignee for Custom clearance within 7days of shipment.
- Quoted price must be valid upto 30/06/2023
- Above information being invited only for the purpose of ascertaining the price without any contractual obligation.

NCCF will be at liberty to distribute the quantity of material (40% maximum) to be supplied among all the technically eligible bidders (bidders who qualify the eligibility criteria and have deposited requisite earnest money along with their bid) at the lowest accepted rates by Tendering Organization subject to acceptance of the lowest rates by the bidders other than L1, after acceptance of NCCF's offer by the Tendering Organization.

NCCF shall be at liberty to terminate the empanelment of Business Associates if it is found that they have competed with NCCF in a particular bid either directly or in partnership/JV with some other firm.
