- The bidder shall have minimum 5 years of experience with working of State Govt./ Central Govt./ Govt. Agency(ies) / Govt. Undertaking company(ies).
- The bidder shall have experience of handling paddy of 10,000 MT in any three years in last 5 years.
- Last year turn over shall not be less than Rs.100 (Hundred) Crore. If audited report is not available, then a certificate from CA and GST returns shall be submitted along with their bid.
- Bidder shall have minimum working capital limit of Rs.20 (Twenty) Crores and submit certificate from concerned bank and date of certificate shall not be 15 days old from the date of Tender.
- Bidder shall have valid ISO 9001-2000, ISO-22000 and GMP Certificate.
