Tender Notice

NCCF Dehradun Branch invites Tender bid from Empanelled Business Associates for supply of FRK (Fortified Rice Kernels) in Uttarakhand to the Rice Mills within stipulated time period in two bid system (Technical & Financial). Supply of FRK to various rice mills in Uttarakhand.

- 1. Name of Work:** Supply of Fortified Rice Kernels with a content comprising of 3 micronutrients (Iron, Folic Acid and Vitamin B12) to delivery destinations at F.O.R. per quintal in Uttarakhand State.
- 2. Scope of Work:** Job work for delivery of Fortified Rice Kernels in packaging of 20 Kg woven HDPE bags with an inner LDPE lining, all confirming to the provisions of Food Safety and Standard Act, 2006 and the Food Safety and Standards (Packing and Labeling) Regulations, 2011 at delivery destinations at F.O.R. per quintal as decided and approved by Govt. of Uttarakhand:-
 1. Supply of FRK containing following micronutrients (i) Iron, (ii) Vitamin B12, (iii) Folic Acid at the levels specified by FSSAI in 20 Kg bags as per quantity allotted and delivery schedule shared by Department of Food, Civil Supplies and Consumer Affairs, Uttarakhand.
 2. Delivery has to be made at Government empanelled Rice Mills identified for milling across all the 06 paddy procuring districts of Uttarakhand.
 3. FRK shall be delivered in 20 Kg woven HDPE bags with an inner LDPE lining and comply with the specifications given below:

Outer Packaging Material Woven HDPE
Outer Bag 80g
Inner Liner Packaging Material : LDPE
Liner Thickness : 250 guage
Packaging size : 20 kg
The bags should be properly stitched by double thread stitching
 4. FRK shall be manufactured using extrusion technology which involves dry mixing of Rice flour and premix followed by addition of water.
 5. All standard/protocols specified under the operational guidelines of the pilot scheme should be in line at the end of FRK producers before its delivery to the rice millers.
 6. Payment will be released only after realization from Food, Civil Supplies & Consumer Affairs Department, Uttarakhand against supplies.
 7. Offer price shall be given in the format attached (Annexure – I) inclusive of GST.
 8. The bids shall be submitted in 2 bid format i.e. Technical Bid and Financial Bid.
 9. Two Packets (each 500 gm) of Fortified Rice Kernels (FRK) samples as per specifications in separate sealed envelope to be submitted along with test reports obtained from NABL accredited laboratory.
 10. Bidders shall give undertaking to comply BIS Standards for Premix, Fortified Rice Kernels and FRK manufacturing machine.

11. Bidders shall also comply with FSSAI standards and GMP, HACCP/ISO 22000:2018 and QMS.

3. Eligibility Criteria:

1. The bidder should be empanelled manufacturer of FRK with NCCF, Dehradun branch as on the date of publication of tender.
2. The bidder should have valid GST registration certificate.
3. The bidder should be registered in India under Companies Act/Partnership Firm/Sole-proprietorship firm or any other registered body having valid registered certificate as on the date of publication of tender. The bidder should be manufacturer of fortified rice kernels.
4. The bidder should have an annual turnover of minimum INR 20 crore (Rs. Twenty crore only) in any one of financial year out of last three (3) financial years (FY 2019-20, 2020-21 and 2021-22).
5. The bidder should have manufactured and supplied Micronutrients Fortified Food/Fortified Rice Kernels of at least 3500 MT in any State within India in any one of last three financial years i.e. FY 2020-21, 2021-22, 2022-23.
6. The bidder should have valid FSSAI license for manufacturing, storing and packing of FRK. The manufacturing unit of the FRK including storage godowns owned by the bidder must meet laid down technical parameters as per FSSAI 99.5 food category.
7. The bidder should have valid ISO 22000 or HACCP certification.
8. The bidder should test FRKs at any NABL accredited Lab and share documentary proof for the same. Certificate of Analysis (COA) is to be obtained from an independent third party NABL accredited laboratory under section 43 of FSS Act 2006 and FSS Regulation 2018 must adopt.
9. The Bidder should give an undertaking in the form of notarized affidavit that the bidding entity and the partners/Directors of the bidding entity have not been convicted in the past 10 years under PFA/FSSA Act/under Essential Commodities Act.
10. The bids of bidder shall be rejected in case it is found that the bidder itself or being part of any entity/group by way of administrative or financial linkage:
 - i. is involved in any corrupt and fraudulent practice in the past.
 - ii. Has history of EMD/Security Deposit Forfeiture.
 - iii. Who was declared, blacklisted or debarred by any Central/State Government/PSU or any of their Agreement has been annulled /foreclosed / discontinued /terminated by any Central/State Government/PSU or Court of law.
11. Any wrong claims and false information will attract rejection of bid and criminal action against the bidder.
12. The bidder should have its own Fortified Rice Kernels (FRK) manufacturing unit under possession.
13. The bidder should submit appropriate certificate issued by Chartered Engineer registered with Institution of Engineers (India), certifying the performance capacity of installed manufacturing unit is sufficient to meet the production demand.

Cost of Tender Fee: Rs. 5000/- Plus GST @ 18%

Earnest Money Deposit (EMD): Rs. 20 Lakh (Interest Free) to be deposited before submission of the bid and in form of RTGS only.

Performance Guarantee: 5 % of total work order as per quantity allotted (Interest Free) after finalization of bid. Performance Security can be submitted in form of NEFT/RTGS. EMD will be adjusted with Performance Guarantee.
