Sir/Madam,


Please refer to letters dated 26.04.2019, 06.06.2019, 19.07.2019, 04.09.2019, 09.10.2019, 17.02.2020 and 20.02.2020 and Emails dated 19.07.2019 15:38, 06.06.2019 18:02, 11.09.2019 13:35, 17.02.2020 14:26 and 20.02.2020 12:54 sent to your establishment regarding want of all required documents including permission of u/p 26(6) of EPF Scheme 1952 issued by EPFO. It is regret to point out here that after so many letters and Email given to you but still you did not submit the letter of Permission U/P 26(6) which is a precursor condition of revision of higher wages cases. Further as matter is sub-judice after the order of Hon'ble Supreme Court dates 06.02.2020 which is read as "Learned Attorney General has pointed out to us that the petition arising out of the judgment of the Kerala high court bearing SLP (civil) number 16721-16722/2019 have been directed to be listed before a bench of the Chief Justice, Honorable Mr. Justice Deepak Gupta and Honorable Mr. justice Aniruddha Bose (Three judge bench) in term of order dated 12th July 2019 and even the review petitions have been directed to be listed in open court. We are of the view that undoubtedly this would have ramification in the present matters and thus it may be appropriate to list the present matter also along with those matters so that a call can be taken whether these matters have to be heard after the decision of that matter or whether the parties in the present matters will also get an opportunity to address the court in the those proceedings."

Further as matter of revision of pension on higher wages is Sub-Judice, therefore all the cases pertain to your estt. /member/Pensioners do hereby return to you, Further whenever case/matter to be decided in the Hon'ble Supreme court, further course of action will be initiated by this office.



Please refer to your above mentioned letters, wherein it was stated that the NCCF has not replied to the EPFO letters dated 26.04.2019, 06.06.2019, 19.07.2019, 04.09.2019, 09.10.2019 regarding submission of required documents including permission letter issued by EPFO under para 26(6) of the EPF Scheme, in this connection it is informed that NCCF has already replied all the above letters of the RPF as per details given below:-

It is needless to mention here that despite the reply given by the NCCF in time, the aforesaid letters were issued by EPFO. Copy of the above EPFO letters and replies given by NCCF are enclosed herewith as per page no -1 to 9 for your kind perusal.

It is further reiterated that the matter pertains to very old period and consequent upon shifting of our Head Office from Nehru Place to NCUI Complex, further records are not traceable including permission letter issued by EPFO under Para 26(6) of EPF Scheme. However the available record in the aforesaid matter has already been submitted to EPFO from time to time.

It is also pertinent to mention here that the NCCF has always compiled its statutory obligation/ directions issued by the EPFO from time to time which has also been accepted by your department. It is also a matter of record that the Provident Fund has been settled from time to time and the pension is fixed/ released by your department to the Ex-employees of the NCCF.

You are therefore requested kindly do the needful.
