## **1. DUTIES AND RESPONSIBILITIES OF SURVEYOR**

- (a) The surveyor shall deploy required number of competent technically qualified staff with proper equipment at storage/delivery point in time as required by NCCF.
- (b) The technical staff of the surveyor will inspect the stock, draw the random samples of pulses, and Grains from the designated godowns/field/Mandi and analyse the sample in accordance with prescribed FSSAI/BIS quality specifications and submit the test reports immediately to NCCF Branches.
- (c) No information shall be shared, published displayed and passed on to any party by the Surveyor or its employees without intimation and consent of NCCF.
- (d) The Surveyor shall be fully responsible for the samples analyzed and test reports submitted to NCCF. In case any of such test reports submitted by the surveyor found to be defective, the entire responsibility for the same shall devolve on the surveyor.
- (e) The Surveyor shall intimate the names, designations, qualifications, experience and the contact numbers of its technical staff to be deployed at storage/delivery point to NCCF for better coordination so that work does not suffer.
- (f) Surveyor shall depute at least one technical staff at storage/delivery point nominated by NCCF and will provide additional number of surveyors at storage/delivery point depending upon the requirement. In case of failure of the surveyor to provide the required number of technical staff with proper equipment's at storage/delivery point as required by NCCF, a penalty of Rs. 500/- per day per manpower will be imposed. In such default, NCCF reserves the right to hire the services of other empanelled surveyors at the cost and consequences of the appointed surveyor.
- (g) The appointed surveyors must not assign the work in full or part to other firm or company or individual.

- 1) No eraser, cuttings, overwriting and correcting fluid in the quotation will be accepted.
- 2) Quotation documents submitted incomplete in any respect and without EMD shall be summarily rejected. Further, NCCF reserves the right to accept or reject any or all quotations without assigning any reason thereof.
- 3) The professional fees/charges should be quoted on per man-day basis both in figures and words. Lab analysis charges for testing as per FSSAI/BIS norms for Pulses and Grains if any, are to be mentioned separately.
- 4) The rates/charges quoted should be exclusive of all taxes, levies etc. Service tax, if applicable, should be mentioned clearly in the bid.
- 5) The offer must have a validity of 60 days from the date of submission of quotation documents.
- 6) During the currency of the agreement, no escalation in professional fees or charges will be allowed except for statutory charges.
- 7) The address given by the surveyor in the quotation documents shall be considered to be the proper and complete business address of the surveyor and any correspondence sent to such address will be deemed to have been delivered to the surveyor.
- 8) The earnest money deposit will be refunded to the unsuccessful parties within one month of finalization of quotation. NCCF will not pay any interest on the EMD.
- 9) Earnest money to the successful bidder will be refunded without interest only after successful and satisfactory completion of the assigned job.
- 10) The payment (subject to TDS and other statutory deductions as applicable) will be released by NCCF within 30 days of receipt of bills along with prescribed documents including attendance sheet, inspection/quality reports or any other document as may be asked for by NCCF from the Surveyor. NCCF shall retain 10% of the amount from each running bill, which shall be released after satisfactory completion of procurement operation.
- 11) The attendance of surveyor should tally with the date of sample collected in presence and duly certified by the respective Branch Manager
- 13) The terms and conditions of the quotation documents will form part of the agreement to be executed between NCCF and successful bidder.
- 14) Each page of the quotation documents must be signed by the authorized signatory of the bidder in token of acceptance of the terms and conditions of the quotation documents.
- 15) The time period validity of agreement will be one year and extendable for one year on same term & condition successfully and satisfactory work performance.

**Eligibility Conditions: -**

- a) Surveyor's agency should have required experience in assaying /inspecting and testing of exported /imported stock of Pulses/Food Grains /Agricultural commodities. Surveyor agency is required to submit copy of job order as supporting documents.
- b) The Surveyor agency shall not be under a declaration of ineligibility of ineligibility for corrupt or fraudulent practices as on date of submission of bid and also not blacklisted or under litigation by any State/Central/UTs Government at the time of submission of application. Surveyor Agency has to provide a self-declaration in this regard.
- c) The surveyor agency should have positive net worth at the time of submission of application. The Chartered Accountant Certificate has to submit in this regard.
- d) The surveying agency Should have presence PAN India, having branch / sub branch / remote offices
- e) The survey agency Should have carried out assaying of minimum of 25 lakh MT of pulses in last three years
- f) The surveying agency should be able to implement digital platform for reporting, data storage and information sharing

**3. FORFEITURE OF SECURITY/EARNEST MONEY**

In case the surveyor fails to fulfil its contractual obligation in any way, NCCF will forfeit the entire earnest money deposit.

**4. TERMINATION**

In case the performance of the surveyor is not found to be satisfactory during the currency of the agreement, NCCF can prematurely terminate the agreement after giving 15 days' notice.

**5. Period of engagement of the surveyor agency**

The agreement to execute between NCCF and Surveyor Agency for a period of One (01) year, may be mutually extended for another one year on the same terms and conditions subject to at satisfaction of NCCF.
