Short Tender notice for purchase of SBT 580 gms Jute Bags for packing of Pulses

NCCF Bhopal branch invites Tender from reputed Jute-Manufacturers/Suppliers/Traders for supply of SBT 580 gms gunny bags for filling of Urad to various Procuring Agencies/Societies etc. Preference will be given to Jute Manufacturers/Dealers/Distributors/Suppliers to participate in the Tender for supply of Gunny Bags (50 Kgs. capacity) to be used in the procurement of pulses under psf.

Sound Jute Manufacturers/Dealers/Distributors/Suppliers can submit their bids till 03-01-2023 up to _04:00 PM at NCCF Bhopal branch office. Situated at 42-A, Vyas Complex, M.P.Nagar, Zone-2, Bhopal. Tender finalization will be carried out on the next working day along with matching with LI rates will be finalized through e-mail communication wherein renderers will be provided a fixed time.

Terms and conditions of the BID:-

1. New Small B-Twill Gunny bags as per specification (94 cm: 57 cm, Weight 580 gms) for packing of Pulses of 50 Kg. There should be no spillage from the filled bag during the normal handling/ transit etc.

Note: 1. BIS test methods shall be applicable.

- 2. Samples of gunny bags need to be submitted along with the lab reports.
- 3.Transportation for supply of gunny bags to various locations i.eDamoh/Ashoknagar/Khurai/Jabalpur/Vidisha etc in the State of Madhya Pradesh has to be arranged by the successful Bidders. Rates shall be inclusive of branding charges, transit insurance of goods, statutory taxes, transit cost, inspection, loading & unloading, supervision charges & NCCF administrative charges. Successful bidders shall have to take transit insurance of the Gunny bags being sent to various consignees. JC empanelled inspection agencies will be appointed by NCCF and inspection will carried out at a particular dispatch point on rotations basis.
- 4. Each bag should be strictly marked with "Manufactured in India" as per the Gazetted notification of Ministry of Textiles..
- 5. The gunny bags are to be supplied within prescribed time period from the date of placement of work order for supply by the branch

- 6. The basic rates per bag shall be quoted on F.O.R basis. The quantity mentioned in the work order to the successful bidders would be purely indicative and quantity can be decreased/ increased/ abolished by the purchaser.
- 7. This is two bid tender comprising of Technical & Financial Bids. The bidder need to submit both the bids in two different envelops. Only technically qualified bidders will be eligible for opening of Financial Bids. Offers shall be valid for 90 days from the date of opening of tenders. During which no escalation in the rates will be allowed.
- 8. NCCF Bhopal branch will be at liberty to distribute the quantity of supply (40% maximum) to be supplied among all the technical eligible bidders at the lowest accepted rates by NCCF subject to acceptance of the lowest rates by the bidders other than L1
