- Agency shall ensure the quality of supplies and have it certified through a third party pre-dispatch inspection by any Government Agency.
- Shipment of the consignment by Sea is to be done within 45 days of issue of Purchase Order.
- 90% Payment will be made after delivery of consignment and confirmation of satisfactory receipt after realisation of payment. The Embassy of India will issue a joint certification along with relevant authorities of the host Government on the consignment complying with specification, acceptable quality and phytosanitary requirements.
- Original documents required to be submitted by the supplier to the designated officer of MEA/ Consignee for custom clearance within 5 days of shipment.


