## DETAILED TENDER NOTICE

Sub.: Export of Non-Basmati Parboiled Rice to Bangladesh.

NCCF interested to export Non-Basmati Parboiled Rice to Bangladesh through eligible empanelled vendor. The Star Export House having experience in the import / export business and having valid license may apply as per details, terms & conditions given below:

### QUANTITY:

One Lakh M.T. 10% (+) (-).

### PACKING:

Rice shall be packed in new Polypropylene (PP) woven bags of 50kg net. The size of 50kg PP woven bag should be 24" x 36", tare weight of empty bags should be 120 Grams minimum.

**PERIOD OF DELIVERY OR SHIPMENT PERIOD:**

Shipment of one lakh M.T. of Non-Basmati Parboiled Rice to Chattogram / Mongla Port within 60 days of opening of Letter of Credit (L/C) or as per terms of buyers.

**PRE-SHIPMENT INSPECTION:**

The seller shall appoint well-known & internationally reputed Pre-Shipment inspecting agency at his own cost to supervise the cargo and issue certificate on (i) quality, (ii) quantity, (iii) weight, (iv) Percentage of broken grain, (v) Content of moisture Percentage, (vi) Percentage of total defects (dead, damaged & discolored grains), (vii) Radioactivity (if not relaxed) and (viii) Foreign materials, (ix) packing etc.

**POST LANDING INSPECTION:**

After arrival of the rice at the port of destination the representatives of the Buyer in presence of the Seller's representatives shall draw necessary representative samples. The sample will be tested in the local office.

**TURNOVER:**

Turnover should have be minimum Rs. 300 Cr.

**TERMS OF PAYMENT:**

The payment will be released to sellers after getting payments from buyers.

**EMD:**

Rupees Ten lakhs in favour of MD, NCCF payable at New Delhi by way of DD/RTGS. The details of RTGS as under:-

**INSURANCE:**

The seller shall be responsible and liable for all matters related to insurance.

## **NON-PERFORMANCE:**

In the event of non-supplying of the rice wholly or partly under the contract the seller shall be held responsible for any consequential loss causing to the buyer arising out of the non-supply of rice.

## **THE LAW COVERING THE CONTRACT:**

The contract shall be governed by and constructed in accordance with the Law of Bangladesh.


## **ARBITRATION:**

- ❖ Preference will be given to firm who has successfully exported rice to Bangladesh earlier.
- ❖ Validity of Bid will be one month.
- ❖ The firm who has filed any case against NCCF or NCCF has filed against the party will not considered.
- ❖ EMD of the unsuccessful bidders will be refunded within one month of finalization of tender.
- ❖ Tender without EMD will not considered.
- ❖ EMD will be forfeited in case of bidder asked for modifications or not accept the contract after award of the tender.
- ❖ All documents should be self attested.
- ❖ Conditional bids will not be considered.
- ❖ NCCF reserves the right to accept or reject any bid without assigning any reason.
