Sodic Lands III Project and intends to apply part of the proceeds of this financing to eligible payments under the contract for which this invitation for quotations is issued.
- You are invited to submit your most competitive quotation for the Certified or Truthful seed of the following fodder crops:-

3. Bid Price

- a) The contract shall be for the quantity as quoted by the bidder. Corrections, if any, shall be made by crossing out, initialing, dating and re writing.
- b) **All duties, taxes and other levies payable on the raw materials and components shall be included in the total price including packaging and printing as desired.**
- c) Sales tax in connection with the sale shall be shown separately.
- d) **The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.**
- e) The Prices shall be quoted in Indian Rupees on FOR basis only.
- f) **The seed should be Certified / truthful seed along with germination and purity report of the seed to be supplied by the bidder. Preference will be given to certified varieties of seed.**
- g) If seeds found below the standard of Certified / truthful seed ,the seeds will be returned to the supplier on his own cost and supplier can be blacklisted for future supply.
- h) The supplier representative should be present at the time of supply of seed for sampling of seed which will be taken in their presence by the purchaser.
- i) The bidder should quote only the rate of variety mentioned in quotation format. If bidder quotes different variety other than variety specified in column C of format for the quotation then quotation will not be considered.
- j) The Quantity specified in column 3 of table 1 above is the total quantity of seed needed for all distric project units under UPSLRIIP. The rate quoted by the bidder may comprise of anyone or more of the varieties specified in column C of format, but **the quantity available of each variety must be clearly specified.**
- k) Fodder seed should be packed in 4.0 Kg in new cloth Bags duly stitched and labelled in black colour with the following:

**Multicut Jwar / Cowpea Net weight (4kg per bag)
and warning**

**“NOT FOR SALE”, ‘PROPERTY OF UPBSN/UPSLRIIP
Zaid (Year 2015).**

- l) There is no inter-se priority between the varieties mentioned in column C of format of the fodder seed.
4. Each bidder shall submit only one quotation to bid for. This is to clarify that if the bidder has more than one firm in different name with same ownership then he shall not apply for the same with names of different firms with same ownership. Bidder shall not contact other Bidders in matters relating to this Quotation.

5. Validity of Quotation

Quotation shall remain valid for a period not less than 90 days after the deadline date specified for submission.

6. Evaluation of Quotations

The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which

- (a) are properly signed ; and
- (b) Conform to the terms and conditions, and specifications.

(c) The Quotations would be evaluated separately for each item (Fodder Seed) mentioned.

(d) The rate quoted by the lowest bidder for any item (Fodder) will be purchased first and thereafter second lowest bidder will be considered and so on.

7. Award of contract

The Purchaser will award the contract to the bidder whose quotation has been determined to be ~~substantially responsive and who has offered the lowest evaluated quotation price.~~

7.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.

7.2 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order (sample form attached).

8. Payment shall be made within **45 days after satisfactory delivery of the goods** as per the terms of the contract.

9. Normal commercial warranty/ guarantee shall be applicable to the supplied goods.

10.
