## **Tender Notice**

NCCF, Mumbai Branch inviting offers from Empanelled Registered Vendors of NCCF to participate in the tender floated by Maharastra State Cooperative Tribal Development Corporation Limited (MSCTDC) Khavti Anudhan Scheme supply of groceries, spices and oils etc. Adivasi Vikas Bhavan, 2nd Floor, Ram Ganesh Gadkari Chowk, Old Agra Road, Nasik-422 022. All the interested bidders of NCCF, Mumbai Branch are requested to submit their detailed proposal on or before 26th November, 2020 (Thursday) sealed cover Branch office directly.

Tender will be offered two bid systems

- 1. Technical Bid.
- 2. Commercial Bid.

Technically qualified bidder is eligible offer quotes.

Bidder has to agree all the terms and conditions remaining same as per the terms and conditions MSCTDC.

## Other terms and conditions for bidders

- 1. Minimum annual turnover in last three Years of the firm shall be Rs 100 cr.
- 2. In case no eligible bidder has Rs 100 cr annual turnover then the order received by NCCF from Govt of Maharashtra shall be split up on prorata basis of turnover amongst all the eligible bidders having a minimum annual turnover of Rs 20 crore. Minimum prorata order shall be for Rs 20 cr turnover. In such case all the eligible bidders shall give an undertaking on Rs 100 stamp paper within 24 hours of opening of financial bid for confirmation of supply of groceries at Lowest rates (L1) received from the eligible bidders.
- 3. All the bidders with turnover of Rs 100 cr and above shall submit 100 % EMD along with the bid and all other bidders having turnover of Rs 20 cr and above shall deposit 50% EMD along with the bid otherwise the bid shall be treated Invalid. In case any bidder is eligible for split order of more than 50% based on the turnover then he shall deposit the balance EMD within 24 hrs of such advice given by NCCF.

- 4. EMD amount is Rs.2.33 Cr including Tender Fees. Payment method is by the way of RTGS only.
- 5. In case of split orders all the eligible bidders will also have to give an undertaking on Rs 100 stamp paper along with their bid to agree to supply material from the processing unit of the bidder who has the largest capacity processing unit. All the bidders shall submit the details of their processing unit along with their bid. Bidder has to give the packaging plant authority or agreement to NCCF for participating in the tender.
- 6. Bids of Bidders who have Legal cases pending Against NCCF or filed by NCCF against them is will not be considered as per bye laws.
- 7. Bidder has to sign and put seal all the documents. Documents without sign and seal will not be accepted.
- 8. NCCF, Mumbai Branch reserves all the right to accept or reject bids received from registered vendors of NCCF, without assigning any reason.
