The 49th Annual Meeting of the General Body of the National Cooperative Consumers' Federation of India Ltd is to be held on 20th September, 2017 at 12.00 Noon in the Committee Room "A", NCUI Complex at 3, Siri Institutional Area, August Kranti Marg, New Delhi - 10016.

In accordance with Bye-Law 20(b) of NCCF and section 38(3) of the Multi-State Cooperative Societies Act, 2002, the Member organizations can represent only through the Chairperson or the president or the Chief Executive or member of the Board if such a member is so authorized by the Board of such cooperative societies or other Multi-State Cooperative Societies, as the case may be and where there is no Board of such cooperative societies or other Multi State Cooperative Societies, for whatever reasons, through the Administrator by whatever name called.

We are enclosing herewith a specimen copy of instrument of nomination, which may be sent back to NCCF duly filled in alongwith the official seal and a photograph of the nominee duly attested by District/Asstt. Registrar of Cooperative Society or Manager/Branch Manager of Cooperative Bank or where the society is holding its account. For updation of the record of the member societies, you may also send latest address alongwith telephone Nos. /Email and Certificate of registration of your Society/ Member stores.

At the last moment, if there is any change in the representation of the delegate on the Annual General Meeting of NCCF, the newly nominated delegate should carry the fresh resolution of the Society alongwith identification form duly filled in and attested by District/Asstt. Registrar of Cooperative Societies or Manager/ Branch Manager of cooperative bank or where the society is holding its account with the official seal.

In view of the above, the eligible Member Cooperative Societies are requested to place the matter before their competent authority nominating their representative on the General Body of NCCF in accordance with Section 38 (3) indicated above and send an attested copy of the fresh resolution of the competent authority nominating their representative on the General Body of NCCF by 07th September, 2017 positively so that the meeting notice of the Annual General Body and Agenda notes may be sent to your delegate in time.
