- The organization reserves the right to accept or reject the highest tender received or bid made without assigning any reason therefore.

The successful bidders shall have to remit/pay 25% of the accepted bid amount (EMD can be reckoned) immediately on acceptance of the bid by the organization and the balance amount shall be paid within 7 days of acceptance of the bid by the organization. The EMD of the highest bidder who fails to deposit 25% of his bid shall be fully forfeited.
